



9th ANNUAL WINGS EATING CONTEST: OFFICIAL CONTEST RULES

1. ELIGIBILITY:

Contest is open to all, 19 years or older. Employees of any WINGS Restaurant or Pub are not eligible to enter.

2. TO ENTER:

Hopeful participants can enter online at www.greatwings.ca/WINGSCChamp2018 and must submit their entry before no later than **November 8th at 11:59pm**. Only those randomly selected to participate will be contacted. If selected to advance to the Locations Round, the participant must sign and complete all necessary documents including these Contest Rules, Liability Waiver, and Photo Release.

3. CONTEST RULES:

There are 10 participating locations, Abbotsford, Surrey, Quesnel, Vancouver, Coquitlam, Vernon, Terrace, Langley, Kelowna (Rutland), and Burnaby WINGS. Once you enter at one location, you may not enter again at that location or any other location. The location contest runs on November 15, 2018 and the Grand Finals is on November 29, 2018 at WINGS Surrey. Location Round: 5-8 contestants (more if the Manager at the specific WINGS wishes), 1 advance to Grand Finals. Grand Finals Round: 10 contestants (1 finalist from each location). Please sign up at your favourite location prior to deadline date of November 8th, 2018. Your place will be confirmed by November 12th. 5-8 contestants will be chosen randomly for the location round. The object is to be the first person to eat 2 pounds of WINGS, all drumettes. The WINGS will be our famous Buffalo flavour. Contestants may eat either sitting or standing in their designated areas using hands. Contestants may only drink water during the competition. Contestants must complete eating one chicken wing before proceeding to the next chicken wing. The judge may ask a contestant to finish off a wing that has not been fully eaten. Contestants must wait for the start signal to begin eating and may not touch any WINGS prior to the start signal. The last wing must be completely chewed and swallowed. If a contestant throws up, he or she will automatically be disqualified. Judges will be on hand to assure adherence to contest rules and to disqualify contestants who fail to adhere to the rules. In the event of a tie, after a brief interval, a 2 minute eat-off with the participant who eats 1lb of WINGS the fastest will be crowned the winner.

4. GROUNDS FOR DISQUALIFICATION INLCUDE:

- False or incomplete entry form or liability waiver
- Under the influence of any substance
- Starting prior to the start signal
- Throwing up
- Interfering with other contestants
- Doing damage to property including plates and glassware
- Unacceptable behavior such as swearing, spitting, taunting.

WINGS reserves the right to disqualify any contestant for any reason without explanation

5. PRIZING & AWARDS:

Contestants will receive a \$25 WINGS gift certificate for being selected for the Location Round. One winner from location will win 1lb free WINGS monthly for a year, induction into the location’s Hall of Fame and proceed to the Grand Finals. The Grand Prize Winner will receive \$500.00 cash and a trophy to display at their WINGS location for one year.

6. ACKNOWLEDGEMENT OF RISKS AND WAIVER LIABILITY:

Contestant acknowledges that there are risks of personal injury, illness, and possible loss of life, and risks of damage to or loss of personal property, which may result from participating in this contest. Contestant voluntarily enters WINGS Eating Contest and assumes all of these risks. Contestant, as a condition of entry, agrees to indemnify, defend and hold harmless WINGS Restaurants & Pubs and affiliated companies, their vendors, their advertising, promotion and public relations agencies, co-sponsoring companies and their affiliates and agencies, and all officers, directors, employees and agents of the aforesaid entities, from any and all claims and costs, including lawyers’ fees, relating to, arising from or in connection with participation in this contest or the receipt or use of any prize. In so doing, contestant releases and indemnifies the aforesaid entities and individuals from liability for injuries or damages of any kind arising from or in connection with participation in this contest or the receipt or use of any prize. In no event shall WINGS Restaurants & Pubs be liable for acts or omissions arising out of or related to the Contest or that contestant’s participation in the contest.
